## 552.215-71 EXAMINATION OF RECORDS BY GSA (MULTIPLE AWARD SCHEDULE) (JUL 2003)

The Contractor agrees that the Administrator of General Services or any duly authorized representative shall have access to and the right to examine any books, documents, papers and records of the Contractor involving transactions related to this contract for overbillings, billing errors, compliance with the Price Reduction clause and compliance with the Industrial Funding Fee and Sales Reporting clause of this contract. This authority shall expire 3 years after final payment. The basic contract and each option shall be treated as separate contracts for purposes of applying this clause.

In accordance with Clause 552.215-71, IOAs will conduct an examination of the contractor s sales tracking system to determine if adequate process controls and procedures are both in place and being followed to ensure sales are accurately and completely captured and reported in accordance with contract requirements.

In order to determine if the contractor has adequate process controls and procedures in place, the IOA must review all sales data (not only those sales the contractor considers reportable via the 72a or TDR websites). Depending on the size and scope of the contract, the IOA shall request anywhere from one month to up to a year of data (including government as well as other sales such as commercial) in a spreadsheet format. If the IOA finds problems with the sales tracking system, additional data may be requested. The IOA will provide an example of what fields should be included in the report. This data will be utilized to determine if the contractor's sales tracking system is adequate, if the pricing and delivery terms are being met. Additionally, the IOA will request additional documentation such as invoices, purchase orders, task orders and modifications, in order to complete the Contractor Assessment.

All documentation and data is considered confidential and will not be shared outside of GSA. The IOA does not store data once the Assessment has been completed, though some documentation may be included when the IOA submits the Contractor Assessment Report and is stored in the Electronic Contractor File System for future GSA reference.

All other terms and conditions remain the same.
